Dean Sanderson, Public Works Director, appeared before the Board with prepared agreement between Douglas County and Finney & Turnipseed, consulting engineers, Topeka, Kansas. This agreement is relative to field surveys, designs, plans, specifications, and construction engineering services for bridges and approach grading to Bridges No. 12.75N 15.00E. All costs of service to be provided is related in the agreement which is on file in the Commission Office. It was moved by Mr. Heck that this agreement be approved, seconded by Mr. Stoneback, and carried unanimously.

Judge Elwell appeared before the Board to request reclassification of Linda Pringle from clerk to chief clerk of Juvenile Court at a salary of \$415 per month effective November 1, 1973. Judge Elwell also requested a one-year length of service salary increase for Kathy Rest of \$30 per month, bringing her salary from \$365 to \$395 per month, effective November 1, 1973.
