Mr. Bill Womack, Chairman of Lawrence-Douglas County Regional Planning Commission, appeared before the Board requesting the acceptance of the boundary study of the proposed Wakarusa Rural Water District, generally located in the southwest quarter of Douglas County and in the northern part of the northwest quarter of Franklin County. It was moved by Mr. Heck that the Board approve the recommendation of the Lawrence-Douglas County Regional Planning Commission relating to the Wakarusa Rural Water District, seconded by Mr. Stoneback, and carried unanimously. The Board noted that the recommendation of the regional planning commission to the County Commission was to the effect that approval be granted because the boundary as proposed does not leave any area unserviceable by other rural water districts and that the proposed water district does not conflict with any known plans of other existing or proposed water districts.
