Ernest Coleman, revenue sharing consultant, appeared before the Board with the following recommendations: That the proposed 'Small Claims Court Study' be approved and funded 50% or a maximum of \$1300 total investment from Douglas County General Revenue Sharing Funds provided that the other 50% of funding is committed from other sources before any expenditures of funds are approved, or that the applicant be encouraged to complete a grant proposal for funds from the Governor's Committee on Criminal Administration/Crime Control Act of 1972 and that local matching funds of a maximum of \$150 (5%) be committed if the application is approved. It was moved by Mr. Stoneback that Mrs. Sandra Comenetz be encouraged to complete a grant proposal for funds from the Governor's Committee on Criminal Administration/Crime Control Act of 1972 and that local matching funds of a maximum of \$150 (5%) be committed if the application is approved. After due discussion it was moved by Mr. Stoneback that the Douglas County-Lawrence Planning Director be requested to in turn request the Lawrence-Douglas County Planning Commission to assist the Douglas County Commission in the study and evaluation of various aspects of the involvement of Douglas County in the development of regional planning. Motion was seconded by Mr. Heck and carried unanimously.
