thence westerly along half section line to a point of intersection of said half section line and the A-1 Zoning District Boundary Line, thence southeasterly along said boundary line to a point of intersection of said boundary line and the west line of the SE quarter, thence northerly along half section line to the NE corner of the SW quarter Section 5, said corner being the point of beginning; also a tract contained in the South half of the South half of the SW quarter of Section 4, Township 13 South, Range 19 East, less 3 acres in the SE corner of the described 40 acres.

The above described tracts contain approximately 229.5 acres, more or less, and are generally described as being located North of West 23rd Street (Clinton Parkway) extended, East of Kanwaka Township Road No. 54 (Corps Road) and West of Wakarusa Township Road No. 36 (Dragstrip Road).
