Dick McClanathan, Lawrence-Douglas County Planning Director, presented to the Board Item No. 8 of the Lawrence-Douglas County Planning Commission minutes of June 26, 1974, which is a request to rezone approximately 9 acres from A (Agricultural) to I-2 (Light Industrial), generally located on the North side of Township Road No. 551 approximately 1-1/4 miles North of Big Springs, submitted by Homer Fickel. It was moved by Mr. Heck that the Board accept the recommendation of the Planning Commission which was for the denial of this request for rezoning, seconded by Mr. Stoneback, and carried unanimously. Mr. McClanathan stated that a protest petition has been filed against this rezoning representing approximately 80% of the area eligible to petition in such protest.

Mr. McClanathan then presented to the Board Item No. 6 of the Lawrence-Douglas County Planning Commission minutes of June 26, 1974, which refers to a preliminary plat of Yankee Tank Subdivision Estates. This being a plat of approximately 420 acres generally located north of West 23rd Street (Clinton Parkway) extended west of Wakarusa Township Road No. 36, east of Kanwaka Township Road No. 54 (Corps Road), and West of Wakarusa Township Road No. 36 (Dragstrip Road) all in the South three-fourths of Section 5, Township 13 South, Range 19 East, and in the South 1/2 of the South 1/2 of the Southwest 1/4 of Section 4, Township 13 South, Range 19 East, submitted by Brian S. Kubota, Land Planner for Yankee Tank Investors. Mr. McClanathan explained that the Board needed only to review the preliminary plat, that approval was not required at this time.
