County Clerk Mathia discussed with the Board plans to modernize the County warrant procedure. Clerk Mathia proposed that blank warrants be prepared for each of the six banks of the County with each bank being assigned specific funds for which warrants would be issued. Clerk Mathia explained that this procedure would not interfere with the present method of allocating demand deposits and idle funds investments to the banks of the County. Following due discussion it was moved by Mr. Stoneback that the recommendation of Clerk Mathia be accepted and the banks of our County be advised of this warrant modernization procedure, seconded by Mr. Heck, and carried unanimously.

The bids were from Mid Continent in the amount of \$6.95 per gallon and from Century Laboratories in the amount of \$5.95 per gallon. It was moved by Mr. Stoneback that the low bid of Century Laboratories be accepted, seconded by Mr. Heck, and carried unanimously.

Clerk Delbert Mathia presented the Board a quote on a control check machine, a machine made only by the Burroughs Corporation. The quote being in the amount of \$1103. It was moved by Mr. Stoneback that this machine be purchased, seconded by Mr. Heck, and carried unanimously. This machine is to be paid from revenue sharing funds.

*Proceeds from  
bonds avail-  
able for  
investment*

Proceeds from the recent sale of Judicial-Law Enforcement Center bonds became available for investment. It was agreed by the Board that these proceeds should be immediately invested in U.S. Treasury bills with 182 day maturity. The Board noted deposit in the amount of \$2,750,738.94 in Douglas County State Bank credited to Douglas County Treasurer. This represented \$2,734,000 in bond proceeds and \$16,738.94 accrued interest. It was later reported to the Board by Douglas County State Bank that 182 day U.S. Treasury bills in amount of \$2,850,000 had been purchased at a net cost of \$2,735,032 to yield 7.98%. It was also noted by the Board that the performance bond deposited by the successful bond bidder in the amount of \$56,000 represented the balance of the bond sale proceeds and should be immediately deposited in the bond fund account. It was further agreed by the Board that Douglas County Treasurer Edythe Norman be requested to invest this \$56,000 plus the uninvested accrued interest balance of \$15,706.89 in 182 day U.S. Treasury bills on Friday, July 12, 1974.
