Assessor Darwin Rogers appeared before the Board to request publication of a notice of the Douglas County Board of Commissioners sitting as a Board of Equalization on or after January 15 convening at a time deemed necessary by the Board. Mr. Rogers further recommended that the Board convene for the first equalization session on Wednesday, April 2, 1975, for the purpose of inquiring into the valuation of real property and also on the 12th day of May 1975 for the purpose of inquiring into the valuation of tangible personal property in the County. It was moved by Mr. Stoneback that the Board accept the recommendations of Mr. Rogers, seconded by Mr. Whitenight, and carried unanimously.

Representing the City of Lawrence were: Buford Watson, Manager; Mike Wilgen, Assistant Manager; George Williams, Public Works Director; Jack Rose, Mayor; Fred Pence, Commissioner; and Nancy Hambleton, Commissioner. Also present were County Public Works Director Dean Sanderson and John Frazier, representing the firm of Finney & Turnipseed consultants. Following discussions it was agreed that a memorandum would be prepared setting out general agreements reached at the meeting with reference to the two projects and that a copy of this memorandum would be remitted to the office of Lawrence City Manager, and that a copy of same would be on file in the office of the Board of County Commissioners.
