Community Development Funds public meeting at Lecompton

The Board noted that a public meeting was held at Lecompton in the Lecompton Community Building on Thursday evening, April 3. This meeting was for the purpose of giving opportunity for citizen input into the proposed applications for community development funds being submitted by Douglas County and the City of Lecompton.

Insurance Blue Cross-Blue Shield rates to be increased June 1

Mr. Lyle Ward, representing Blue Cross-Blue Shield Insurance, appeared before the Board to discuss the status of the County coverage. Mr. Ward informed the Board that relative to the County's experience as well as rising costs, the premium cost for Douglas County beginning June 1 would increase in an amount of \$5.67 and \$17.01 for family coverage.

Weed Dept. 2,4-D to be increased to \$4.50/gal for 1975 season

Mr. Byron Patton, District Weed Supervisor, and Mr. Bob Duver, Douglas County Weed Supervisor, discussed with the Board possible change in retail price of 2,4-D for the 1975 season. Following discussion it was moved by Mr. Stoneback that the item in the March 3, 1975 minutes referring to the retail price of 2,4-D be revised as of this date to state that the retail price of 2,4-D for the 1975 season shall be \$4.50 per gallon, seconded by Mr. Whitenight, and carried unanimously.

Fairgrounds: Cottonwood 4-H purchased light outside of Bldg 1

The Board noted receipt of a check in the amount of \$31.50 from the Cottonwood 4-H Club payable to Stanion Wholesale Electric Company for materials for a certain light at the Fairgrounds. Payment for this installation by the Cottonwood 4-H Club was by agreement with the County and the Cottonwood 4-H Club.
