*Blackjack Park: Advertise for harvesting of prairie hay*

It was moved by Mr. Whitenight that the Board advertise for sealed bids for the harvesting of the prairie hay on a part of Blackjack Park as follows: "Sealed bids will be received at the office of the Board of County Commission, Courthouse, Lawrence, Kansas, until 10:00 a.m., July 10, 1975, for the harvesting of the prairie hay on a designated area of Blackjack Park east of Baldwin, Kansas. Bids shall be on a per ton basis for total tonnage removed. Harvesting shall be completed by August 1, 1975. Further information available at office of Douglas County Commission". Motion was seconded by Mr. Heck and carried. Publication dates will be on June 26 and July 3, 1975.

*GCCA: approved grant to continue funding of Co. Corrections project*

Judy Osburn, Director of Corrections, appeared before the Board to discuss the proposed application to GCCA to continue funding of the Douglas County Corrections project for the period October 1, 1975 thru September 30, 1976. The application relates to a total project cost of \$18,160, the applicant's contribution being \$4,189. It was moved by Mr. Whitenight that this application be approved and remitted to GCCA, seconded by Mr. Heck, and carried.

*Capitol Area Agency on Aging: \$1,370 for administrative expenses*

The Board considered communications received recently from members of the Capitol Area Agency on Aging requesting Douglas County to fund prorata administrative expenses of the Capitol Area Agency on Aging in an amount of \$1,370 for the period July 1, 1975 thru June 30, 1976. Following due discussion it was moved by Mr. Whitenight that the Board approve the payment of \$1,370 to the Capitol Area Agency on Aging as our prorata share for the period July 1, 1975 thru June 30, 1976, seconded by Mr. Heck, and carried.

*Clinton Lake: Discussion on construction, roadways, etc.*

Mr. Joe Roberts, Don Fritts, and Kenneth Rowen of the U. S. Army Corps of Engineers, reported to the Board on the status of the Clinton Lake construction, roadways, and other projects being implemented in connection therewith. Following the meeting the date of September 8, 1975, was set for further status report on the Clinton Lake projects.
