B-2 to L-3
(Larry Steel)*

The Board considered Resolution No. 75-30 prepared by Zoning Administrator Wayne Kellum. The resolution relates to and amends a rezoning classification within the unincorporated territory of Douglas County, Kansas, from B-2 (General Business) to I-3 (Heavy Industrial) of the following described property: That part of the East Half of the Southeast Quarter of Section 16, Township 12 South, Range 20 East, which lies East of the Union Pacific Railroad right-of-way and South of Kansas Highway No. 32, Douglas County, Kansas; and described by metes and bounds, beginning at the Southeast corner of said Section 16; thence West, along the South line of said Section 16, a distance of 260.72 feet to the East right-of-way line of Union Pacific Railroad; thence Northeasterly, along said Railroad right-of-way, 409.66 feet; thence North-easterly, on a curve to the right and along said Railroad right-of-way, and a chord distance of 252.36 feet to the South right-of-way line of Kansas Highway No. 32; thence Southeasterly, along said Highway right-of-way, 191.18 feet to the East line of said Section 16; thence South, along the East line of said Section 16; a distance of 589.64 feet to the point of beginning; containing 3.22 acres, more or less. It was moved by Mr. Whitenight that Resolution No. 75-30 be hereby adopted, seconded by Mr. Stoneback, and carried unanimously. The resolution will become effective upon official publication.

The Board considered a memo received from Engineer Sanderson in which he recommends to the Board that in order to make use of federal funds allocated to Douglas County in the projected amount of \$42,959 on a 30% local match basis that Bridge No. 04.50N-00.77E be designated as an "Off System" project which is to include grading. Following discussion of this recommendation the Engineer presented to the Board prepared request for construction project relative to this "Off System" road program. Following due discussion it was moved by Mr. Stoneback that this request to the State Highway Commission of Kansas to designate the aforementioned bridge project as an "Off System" road project be approved, seconded by Mr. Whitenight, and carried unanimously.
