Dick McClanathan, Lawrence-Douglas County Planning Director, presented to the Board Item No. 11 of the minutes of the Lawrence-Douglas County Planning Commission meeting of September 24, 1975. This item refers to a request for a Conditional Use Permit to allow for the development of a Youth Ranch for Boys which will provide intensive and comprehensive counseling, occupational and/or vocational training and rehabilitation on an approximately 140 acre tract, generally described as being located along the east side of Wakarusa Township Road No. 10-A approximately 3/4 mile south of Highway No. 10, and along the north side of Wakarusa Township Road No. 80 east of said Township Road No. 10-A, submitted by Mrs. D. C. O'Connell and Youth for Christ, Int. Following Mr. McClanathan's presentation and comments relative thereto by Mr. Ernest Coleman, representing sponsors of the project, it was moved by Mr. Whitenight that the Board approve the recommendation of the joint planning commission which recommendation was for approval of the conditional use permit subject to the following three conditions:
