Engineer Sanderson presented the Board Resolution No. 75-39 which resolution pursuant to K.S.A. 8-532 establishes a speed limit of 50 miles per hour on the following described county road: Beginning at the Southwest corner of Section 16, Township 15 South, Range 21 East, in Douglas County, Kansas, said point being on the county line between Douglas and Franklin counties and on the center line of Federal Aid Secondary Route 209; thence North on the center line of said Route approximately two (2) miles to the Northwest corner of Section 9, Township 15 South, Range 21 East (U. S. Highway 56). Following due discussion it was moved by Mr. Whitenight that Resolution No. 75-39 be approved, seconded by Mr. Stoneback, and carried unanimously.
