Mr. Earl Van Meter, Douglas County Extension Agent; and Ernest Coleman, federal funds consultant, appeared before the Board to discuss with the Board their recommendation relative to the employment of David Kehler as a Douglas County 4-H Agent under the Douglas County CETA Title VI program. Mr. Van Meter recommended the employment of David Kehler with his salary being funded in the amount of \$393 by Douglas County CETA Title VI funds, January 1, 1976 through June 30, 1976, it being understood that the balance of this salary will be paid by the State of Kansas. It was moved by Mr. Stoneback that this recommendation be approved, seconded by Mr. Whitenight, and carried unanimously.

Ted McFarlane, ambulance manager, presented the Board quotes relative to the purchase of a typewriter for his department. The Board discussed with Ted McFarlane, ambulance manager, the matter of increasing the insurance limits on our ambulance vehicles. Following due discussion it was moved by Mr. Whitenight that we instruct Mr. McFarlane to secure coverage of all vehicles with limits of \$100,000/\$300,000/\$100,000 to be effective immediately, seconded by Mr. Stoneback, and carried unanimously.

Ernest Coleman, community development funds administrator, discussed with the Board the final draft of the Penn House housing rehabilitation services grant handbook. Following due discussion it was moved by Mr. Whitenight that the handbook be tentatively approved with the understanding that corrections and revisions may be made as deemed necessary as the rehabilitation program is implemented, seconded by Mr. Stoneback, and carried unanimously.
