A delegation representing Douglas County Child Care Association discussed with the Board the funding needs of that organization for the year 1976. Following due discussion it was moved by Mr. Whitenight that we commit \$5,000 from our matching fund line item to provide support to Douglas County Child Care Association for the year 1976, with this amount subject to subsequent review, and that we petition the state SRS to support our local matching fund efforts with state funds and to establish a priority system for allocation of these services to the most needy potential recipients with one-half of the \$5,000 immediately available and the other one-half available after July 1, 1976.
