Darlene Hill, Budget Director, presented to the Board and discussed with the Board statement of fund balances as of February 29, 1976, and a statement of expenditures and balances of budget appropriations from January 1, 1976 to March 15, 1976.

Engineer Sanderson presented to the Board proposal from Barnett, Stuart and Dow, Inc., to provide geological investigations and reports for certain described eight bridges with the proposal setting out that work required to be accomplished. The proposal calls for total payment of \$6,305 for this geology on eight specified bridges. After due review it was moved by Mr. Stoneback that this proposal be approved, seconded by Mr. Whitenight, and carried unanimously.

Counselor Young along with attorney Byron Springer, who represented Mr. Vernon Harris, appeared before the Board to report their findings relative to width of right-of-way of a three-quarter mile segment of Road No. 433 on the section line between Sections 20 and 21, Township 13S, Range 20E. Mr. Young and Mr. Springer reported that their research lead to their joint conclusion that the aforesaid section of road has a right-of-way fifty feet in width.
