Harrell, Leslie Harrell, Vernon Harrell, Leo Harrell, Irene Steele, Alma Houk, Roberta Medley and Evelyn Lasley, and Douglas County. The contract calls for the lump sum payment of this contract in the amount of \$1,500 to be paid as follows: Seven-eighths of the proceeds to be paid by Douglas County in escrow with Lawrence National Bank & Trust Company, Lawrence, Kansas, and one-eighth shall be paid directly to Alvin R. Harrell. It was moved by Mr. Whitenight that this contract agreement be approved, seconded by Mr. Stoneback, and carried unanimously.
