Bridge:*The Board noted receipt of communication from the State of Kansas Division of Water Resources granting approval of plans relating to proposed channel change on the following proposed new bridge structure: Bridge No. 00.00N-17.63E across a tributary of the East Fork of Taury Creek, at a location in the Southeast Quarter (SE $\frac{1}{4}$) of Section 15, and the Northeast Quarter (NE $\frac{1}{4}$) of Section 22, both in Township 15 South, Range 20 East, Douglas and Franklin Counties, Kansas. The Board considered the funds from which the Computer Service Agency subscription in the amount of \$65,155.59 due July 15, 1976, would be paid. Schlink and Goldie I. Schlink, husband and wife, said property described as a part of the SE $\frac{1}{4}$ of Section 3, Township 14 South, Range 18 East, in Douglas County, Kansas. The appraisers report was in the amount of \$3100 and after discussion it was moved by Mr. Whitenight that we direct the office of County Engineer to pay this amount and in addition appraisers fee and publication costs to the Clerk of the District Court, seconded by Mr. Stoneback, and carried unanimously.*Treasurer's

Following the opening of the bids by Deputy Treasurer Betty Leslie relative to nine separate amounts totaling \$4,000,000 of "repurchase agreements" dated 12:00 noon, July 1, 1976, and maturing 12:00 noon, July 15, 1976, it was recommended by Deputy Treasurer Leslie to the Board that the bid for the total amount made by University State Bank at an interest rate of 4.37% be accepted with a total net interest return of \$7182. Following consideration of the recommendation it was moved by Mr. Whitenight that we accept the recommendation of the deputy treasurer, seconded by Mr. Stoneback, and carried unanimously.
