This item relates to a request for a Conditional Use Permit approval to allow a landfill on a 11.95 acres, more or less, tract generally described as being located on the east side of Michigan Street, north of the Kansas Turnpike, submitted by Glenn Barnard. Following considerable discussion of this request it was moved by Mr. Whitenight to continue this matter to October 27, 1976, at 10:00 a.m., and request Mr. Barnard to be present at that time to discuss with the Board his plan of operation for the landfill and further discuss with Mr. Barnard proper procedures for the landfill, seconded by Mr. Stoneback, and carried unanimously.
