At 11:00 a.m. the Board held a hearing relative to petition for attachment of certain described adjoining lands for Rural Water District No. 3, Douglas County, Kansas, with attorney Walter Stumbo representing the petitioners. The Board noted the following:

1. Proof of publication and mailing of petition and notice of hearing is on file.
2. Metes and bounds description of lands to be annexed to Rural Water District No. 3 has been certified by Attorney Walter Stumbo.
3. That lands described in petition for annexation to Douglas County Rural Water District No. 3 are without an adequate water supply.
4. That attachment of lands described in the petition will be in best interest to promote the public health, convenience and welfare of the community.
5. That the Board of Directors of Rural Water District No. 3 have acknowledged notice of said petition and voiced no objection.

Giving effect to these facts it was moved by Mr. Stoneback that the Board of Douglas County Commissioners declare that lands described and known as Tracts No. 1, 2, and 3 as set out in petition filed in the office of the Clerk of Douglas County on November 8, 1976, be attached to Douglas County Rural Water District No. 3, seconded by Mr. Whitenight, and carried unanimously. Copy of the petition is on file in the commission office.
