The Board met with Emergency Preparedness Coordinator Travis Brann; Ernest Coleman, federal funds consultant; Mike Wildgen, assistant city manager; Richard Stanwix, chief of police; and Robert Cassity, representative of the Douglas County Sheriff's Office. This meeting was called to review the emergency communications plan which had been submitted to the State Emergency Preparedness Agency. There was lengthy discussion by Mr. Brann and others on the concept presented in this plan and it was generally agreed that the plan as submitted was a proper course. It was agreed that Mr. Brann would prepare an actual floor plan of the emergency preparedness space which would show placement of the various proposed pieces of equipment and the communications capacity contained therein. The Board then reviewed with these two men the proposed contract for Phase III of the comprehensive plan. The Board reviewed in detail the various work items that are proposed and alternatives that were offered on several of the work items.
