(2) Mr. Williams then recommended Change Order No. 1 to General Contract No. 2 which deducts a number of items from the original contract in the total amount of \$46,700 which makes the new total contract sum with the change order to be \$192,043. After discussion on this recommendation it was moved by Mr. Neis that this be approved, seconded by Mr. Whitenight, and carried.

(3) Mr. Williams recommended acceptance of the bid and execution of the agreement with Lake Country Hardware, Inc., Springfield, Missouri, for the bid on hardware and hollow metal for the remodeling project of the Douglas County Courthouse. The amount of this contract is \$32,665. After review it was moved by Mr. Neis that this bid be accepted and contract executed, seconded by Mr. Whitenight, and carried.

(4) Mr. Williams recommended acceptance of the bid and execution with Norris Bros., Inc., Lawrence, Kansas, on mechanical and electrical contract for the remodeling of Douglas County Courthouse project in the amount of \$293,400. After review it was moved by Mr. Neis that this recommendation to accept the bid and execute the contract be accepted, seconded by Mr. Whitenight and carried.

(5) Mr. Williams recommended the acceptance of the bid and execution of the contract for fire protection for the remodeling of the Douglas County Courthouse with Security Sprinkler, Inc., Kansas City, Missouri, in the amount of \$18,189.
