Ambulance:
Bids opened
for FM equip.

At the advertised hour of 11:00 a.m. bids were opened on FM radio equipment which will be housed at the Lawrence Memorial Hospital in connection to be used with the ambulance service. Two bids were received. The first from Motorola Communications & Electronics, Inc. in the total amount of \$6233 and the second bid received was from General Electric in the total amount of \$5153.25. It is noted that the Motorola bid notes no exceptions are taken to the equipment, tower, and antenna system bid specifications, and that a list of exceptions is included in the General Electric bid. After a brief review of these bids it was moved by Mr. Neis that we submit the bids to Ted McFarlane, ambulance director, for his review and later recommendation to the Board. This motion was seconded by Mrs. Bradley and carried unanimously.

No further business, the Board adjourned to meet on Friday, April 8, 1977, for the sole purpose of canvassing ballots of the April 5, 1977, general city and school board election. All other business will be conducted on Monday, April 11, 1977.

Change in price
of vacuum

Al Skeet, maintenance supervisor, appeared before the Board to request a modification in the agreed upon price for the Model 70 vacuum sweeper for leaves and grass which was incorrectly quoted from E-Z Rake, Inc., Lebanon, Indiana from which we agreed to purchase this item. It was indicated by this company that a substantial change in price on this product had taken place and that an additional charge of \$76 would be required which brings the total amount necessary to purchase this item to \$801.
