Travis Brann, emergency preparedness coordinator, appeared before the Board to recommend that the date for receiving bids on communications equipment for the EOC be set off from the original date of 28 April for fourteen days or until 12 May 1977 at the hour of 10:00 a.m., C.D.T. This recommendation is based on a request from one of the potential vendors who indicated late receipt of the specifications and insufficient time to prepare bid by the 28 April date, and also that an omission had been made in the original specifications of two crucial pièces of equipment which will be added by addendum and distributed to those who are receiving the specifications. After discussion of this recommendation it was moved by Mr. Neis that this recommendation be approved, seconded by Mrs. Bradley, and carried unanimously.

Comm. Dev. app. reg for bids on on old Castle Museum in Balde

Ernest Coleman, community development funds consultant, appeared before the Board to request approval of a notice to bidders on a project for rehabilitation/restoration work on the old Castle Museum grounds in Baldwin, Kansas which will be funded by community development block grant funds. The notice will indicate that bids will be received at the Board of County Commissioners in the basement of Douglas County Courthouse, 11th & Massachusetts, until 10:00 a.m., Wednesday, May 11, 1977, and at that time publicly opened. After review of this recommendation it was moved by Mr. Neis that this notice be published as recommended. seconded by Mrs. Bradley. and carried unanimously. published as recommended, seconded by Mrs. Bradley, and carried unanimously.

The Board met with Buford Watson, city manager of the City of Lawrence, and members of his staff to conduct a general discussion on some matters of mutual interest between the City of Lawrence and Douglas County. Among the matters discussed with no firm decision being reached on any subject were the following: The question of sharing of cost on the new one month telephone contract, the sharing of cost on new air handling equipment for the judicial and law enforcement building, the question of needs for additional space for the Bert Nash Mental Health and public health offices. There was general discussion about the relationship between the City of Lawrence and Douglas County regarding the emergency preparedness. Mr. Watson pointed out in this regard that John Kasberger, fire chief, has been appointed by the city as their emergency preparedness coordinate that activity. Mr. Watson and Mr. Kasberger agreed that an individual would be appointed from the fire department to become a radiological officer for Douglas County and that this individual would be assigned to a school for training for this position soon to be held. It was agreed that this schooling would be arranged for through the emergency preparedness coordinator so that federal matching funds would be available on the training expense. Finally, the Board discussed for informational purposes the proposed sewer district which lies between Sixth Street and Twenty-Third Street, lying generally west of Alvamar and west of Monterey Way north of Fifteenth Street. After full and lengthy discussion on these above matters it was agreed between the Board and Mr. Watson that a meeting between the Board of Commissioners and City Commission of the City of Lawrence would be desirable and such a meeting was tentatively scheduled for Thursday afternoon, 28 April at 3:30 p.m., in the city offices.
