Change amount  
of funding

Susan Zuther, director of volunteers in court, appeared before the Board to present a change in the amount of local match that is required for the GCCA grant which funds in part the operation of the office of volunteers in court in Douglas County. This change is brought about due to a revision of the assumption of cost policy at GCCA which lowers the federal share of funding on this particular project as well as lowers somewhat the state funding. The original submission for the grant to GCCA indicated a commitment of local funds in the amount of \$14,962. The addition that is required due to this change in policy will be \$3,021.56 of local funds which brings the figures for the project to stand as follows:

Total net cost of the project	\$25,887.00
Federal funds	7,487.47
State funds	415.97
Local funds	17,983.56

As an attachment to the documentation on this change let it be noted that the change is recommended to the Board of County Commissioners of Douglas County by the administrative judge of the Seventh Judicial District Frank R. Gray. After complete review of this recommendation which requires additional local funds in the amount of \$3,021.56 which will be funded from the unified courts budget, it was moved by Mrs. Bradley that this change be approved, seconded by Mr. Neis, and carried unanimously.
