Mr. McGee then presented to the Board a utility agreement on Project No. 01.00N-01.90E between the Board of Commissioners of Douglas County, Kansas and the Continental Telephone Company of Kansas which agreement relates to provisions of K.S.A. 17-1901 as to the necessity for movement of utility equipment and facilities which are located on county right-of-way. The agreement indicates that relocation of existing facilities which are currently located on private easements will be paid for by Douglas County and that those facilities within county right-of-way will be moved at utility company expense, and that the construction or alterations of the company's facilities shall be completed within 30 days after the county furnishes to the company the required information. After review of this agreement it was moved by Mr. Neis that this utility agreement be approved, seconded by Mrs. Bradley, and carried unanimously.
