Sheriff Rex Johnson appeared before the Board to request a one-year merit increase for Donald Crowe in the amount of \$49 per month, bringing his salary from \$822 to \$871 per month effective June 1, 1977. Tom McGee, engineering division manager, appeared before the Board to present a contract for right-of-way easement on Bridge Project No. 01.00N-07.87E between Roger D. Johnson and Beverly K. Johnson, husband and wife, and Edward D. Johnson and Wanda M. Johnson, husband and wife, and the Board of County Commissioners of Douglas County, Kansas for a lump sum amount of \$306.24. This figure is based on approximately 0.42 acres of right-of-way easement, 0.014 acres of temporary easement for construction, and a lump sum payment as an allowance for eight walnut trees included within the area described. After review of this contract it was moved by Mr. Neis that this contract be approved, seconded by Mrs. Bradley, and carried unanimously.

Mr. McGee then presented to the Board Resolution No. 77-21 which indicates that a change in the gross weight limit for Bridge No. 12.00N-11.30E on County Road No. 207, better known as the Clinton Blacktop Road, shall be posted six tons. This change in weight limit is based on a state reinspection of said bridge which was conducted on 8 April 1977 by Mr. H. H. Hobrock which indicates a number of findings as to the condition of the bridge and includes a recommendation that the bridge be posted for a weight limit of six tons. After review of the recommendations of Engineer Sanderson and the reinspection report by Mr. Hobrock it was moved by Mrs. Bradley that Resolution No. 77-21 be adopted, seconded by Mr. Neis, and carried unanimously.

Ernest Coleman, federal funds consultant, appeared before the Board to recommend that public notice be provided that applications for the use of revenue sharing funds will be accepted until 5:00 p.m. on 5 July 1977 with use hearings to be held during the morning of 7 July 1977. This notice is to be provided through a direct mailing to all former recipients of revenue sharing funds on a contract basis and also be published in all county newspapers. After review of Mr. Coleman's recommendation it was moved by Mrs. Bradley that this notice be given as recommended and that the hearing date of 7 July 1977 be established, seconded by Mr. Neis, and carried unanimously.

Mr. Coleman in conjunction with Bob Duver, director of noxious weed department, recommends the employment of Mr. James M. Robertson of Winchester, Kansas to fill the position of grounds-maintenance assistance within the noxious weed department at a salary of \$558 per month effective 22 June 1977. This position is to be funded through CETA Title VI and will expire on 30 September 1977. The Board noted receipt of a series of administrative orders from the Seventh Judicial District of Kansas regarding personnel matters as follows:

Administrative Order No. 12 is an amendment to paragraph No. 2 of the Administrative Order No. 6 dated February 8, 1977 which relates specifically to the procedures involved for the receiving of recommendations from the various departments within the judicial administration with regard to personnel matters.

Administrative Order No. 13 determines that Nancy Lignitz, who has been assistant director for the past year on a half time basis for the Volunteers in Court, be appointed as Acting Director of Volunteers in Court on a full time basis beginning June 13, 1977 at a salary of \$879.00 per month, which salary is within the grant budget of said agency.

Administrative Order No. 14 appoints a new part time secretary for Volunteers in Court. This order appoints Barbara L. Copple to replace Carol Ann Hess as half time secretary. This appointment is effective 1 July 1977 at the rate of \$260 per month. Carol Ann Hess is being transferred to Court Services Division by another order.

Administrative Order No. 15 reassigns Linda Meisel, who is now serving as secretary to Court Services, to Specialized Division C beginning July 1, 1977 at the same salary she is now receiving, namely \$596 per month. This reassignment is necessary due to the resignation of Lucinda Johnson who previously filled this position.
