The Board met with County Counselor Dan Young and with Attorney Charles Stough, who has in times past served as Douglas County bond attorney, to discuss details of necessary arrangements for the bonding of a portion of the County's share of Clinton Parkway and secondly, the requirements necessary for the development of a potential bond issue for the development of sewer district. A lengthy discussion ensued and Mr. Stough asked to take the Board's consideration under advisement for further study and report back to this Board at a later time.

The Board noted receipt of minutes of the Citizens' Committee for Correctional Services for April 21, 1977 and July 7, 1977 submitted by William R. Arnold, secretary.
