Dean Sanderson, director of public works, and Tom McGee, engineering division manager, appeared before the Board to present for the Board's consideration three utility agreements between the Board of Commissioners of Douglas County and Rural Water District No. 4 on the following bridge projects: Bridge No. 11.40N-21.00E, Bridge No. 09.00N-21.38E, and Bridge No. 11.40N-19.00E all located in Douglas County. The agreements are in accordance with the terms of K.S.A. 17-1901 and indicate that the relocation of existing facilities which are currently located on private easement will be paid for by Douglas County and that those facilities within county right-of-way will be moved at utility company expense, and that the construction or alterations of the company's facilities shall be completed within 30 days after the county furnishes to the company the required information. After discussion it was moved by Mr. Neis that the three utility agreements be approved, seconded by Mrs. Bradley, and carried unanimously.

Mr. Sanderson and Mr. McGee then presented to the Board Resolution No. 77-32 which indicates that this Board finds and determines upon the basis of an engineering and traffic investigation that the speed limit for the following described county road or highway: Beginning at a point approximately 1365.00 feet North of the Quarter Section corner between Sections 28 and 29, Township 13 South, Range 19 East, said point being on the center line of F.A.S. Route No. 206; thence Northerly on said center line approximately one and one-quarter (1 1/4) miles to the Northwest corner of Section 21, Township 13 South, Range 19 East is greater than is reasonable or safe under the conditions found to exist on the above described county road or highway. It is therefore resolved by this document that the Board of Commissioners of Douglas County, Kansas establish a speed limit of 40 miles per hour within the area above described and that the speed limit of 40 miles per hour is hereby determined to be a safe and reasonable speed limit for the conditions which exist on the above described county road or highway. This speed limit shall become effective when appropriate signs giving notice thereof are erected upon the county road or highway above described. After discussion it was moved by Mr. Neis that Resolution No. 77-32 be adopted, seconded by Mrs. Bradley, and carried unanimously.
