Jim Williams, representative of the architectural firm of Peters, Williams & Kubota, who are the architects on the project for remodeling of the Douglas County Courthouse, appeared before the Board to present a number of contracts for that project for which bids were received on 28 December 1977 as follows:

- (1) Contract between the Board of County Commissioners and Willowridge Landscaping for sprinkler system in the amount of \$1662.
- (2) Contract between the Board of County Commissioners and Pence Garden Center for landscaping in the amount of \$2944.65.
- (3) Contract between the Board of County Commissioners and Dover Elevator Company for elevator and cab contract in the amount of \$27,589 and \$72 per linear foot for rock excavation.

After review of these contracts it was moved by Mr. Neis that these contracts be accepted and that funds be committed from the 1977 General Fund budget to cover these contractual obligations using the commissioners line item. This motion seconded by Mrs. Bradley and carried unanimously.
