The Board considered Resolution No. 78-17 which in accordance with the terms of K.S.A. 19-436 requires the Board of County Commissioners to determine the total costs to be incurred by the Douglas County Appraiser's office and itemiz and identify the same in the budget of the County; and whereas, said statutes provide that the Board of County Commissioners give public notice that all taxes levied to pay the costs of the County Appraiser's office are exempt from the aggregate tax levy limitation imposed under the provisions of K.S.A. 79-5001 to 79-5016 inclusive. It is therefore resolved by this document that public notice be given as required by K.S.A. 19-436, that the total costs to be incurred in operating the office of the County Appraiser will be \$175,000 for Fiscal Year 1979, and that all taxes levied to pay this cost shall be exempt from the aggregate tax levy limitation of Douglas County, and if with-in sixty days after the last publication of this notice a petition signed by electors of Douglas County equal in number to not less than five percent of the total qualified electors of the County is filed in the office of the County Election Officer requesting an election thereon, such costs shall be within the aggregate tax levy limitation is submitted to and approved by a majority of the electors of the county woting at an election called and held thereon. If within such period no sufficient protest is filed or if the electors approve such proposition at an election called and held thereon, that portion of the tax levies of such county which is levied for the purpose of paying costs incurred by the county in complying with the provisions of K.S.A. 19-430 et seq. shall not be included in computing the aggregate tax levies of the county and as exempt from the limitations imposed under the provisions of K.S.A. 79-5001 to 79-5016 inclusive.
