Vestal, Jr., and Artrice Jean Vestal, which is recorded in Book 326, Page 645, in the office of the register of deeds in Douglas County, Kansas, which easement is described as follows:

Twenty-five feet on the South side of and 45 feet on the North side of the following described line: Beginning 1930.07 feet North of the Southeast Corner of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Thirty-one (31), Township Twelve (12) South, Range Eighteen (18) East, in Douglas County, Kansas; thence South 89°24'16" West to the East line of the five acre tract described above.
