Having completely reviewed the bids received on the rubber tire wheel loader to be purchased for the public works department, it was moved by Mr. Neis that we accept the bid of Sellers Tractor Company in the net amount of \$42,950 based upon the fact that this item offered meets and exceeds all desired specifications for Douglas County for this equipment and in addition presents an overall better value for Douglas County upon the fact that while the list price is over \$7,000 higher than the second bid, the actual net price delivered is slightly over \$2,900 higher than the second place bidder. This motion was seconded by Mr. Whitenight and carried.

*Sewer Dist:  
Review on proposed  
plan*

The Board met with Jack Robinson, representative of Black and Veatch, and with Attorney Charles Stough to review the progress of proposed sewer district in Douglas County. Information was presented on the proposed lay out of the sewer line and for benefit districts and some estimate of costs per acre for the various main and sub-main district as drawn. Two unresolved questions: (1) To clarify with the City of Lawrence their intentions regarding the sewer tie in at the lower end of the district and needed expansion of capacity for the lift station to handle this additional sewered area, and (2) to clarify with the Kansas Department of Health and Environment any potential interest they may have whether the Western Hills Subdivision should be included in this proposed sewer district. It was agreed that these unresolved questions would be answered and that further meetings and discussion would be held before such time that any such meeting would be held for public review of this proposal.

No further business, the Board adjourned to meet on Monday, June 5, 1978.

Sheriff Johnson appeared before the Board to report the termination of Mr. Joe Milligan as of 6 June 1978. The sheriff requested, under the circumstances, the reappointment of a former Sheriff's Department employee, Mr. Edward Pearson, on the basis of being a temporary emergency employee. This appointment to become effective 6 June 1978 with Mr. Pearson to be paid at the rate of \$670 per month. It is intended that Mr. Pearson would be regarded as one of the potential applicants for the vacant positions offered in the corrections department and that he would be adjudged on his merits as against all other candidates for the open positions that are currently being advertised. After discussion it was moved by Mr. Neis that the recommendation of the sheriff be accepted, and that Mr. Pearson be appointed as recommended at the monthly salary of \$670 effective 6 June 1978, seconded by Mr. Whitenight, and carried.

cars. Landmark  
Ford awarded*

At the advertised hour of 10:00 a.m. the Board received sealed bids for two vehicles for the Sheriff's Department. Two bids were received; one from Sanders Motor Company showing a net difference, including trade-in, of \$8638, and the second bid from Landmark Ford which offers a net price, including trade-in, of \$7758.46. These bids as offered were briefly reviewed by Sheriff Johnson and he recommends the low bid of Landmark Ford in the amount of \$7758.46 subject to a provision in the bid which indicates that the quoted bid price from Landmark Ford is subject to availability from Ford Motor Company. It was indicated by Landmark Ford representative, Frank Case, that he would have the information for this Board within two days whether or not these cars would be available. After discussion on the recommendation it was moved by Mr. Neis that it be accepted, seconded by Mr. Whitenight, and carried.
