

- (4) That three notes be placed on the plat. One denoting the floodplain area on the site and one denoting the portion or the site within the floodway, and that the owner or developer meet the requirements of the valley plain district for building construction.

After discussion on this item it was moved by Mr. Neis that we concur in the recommendation of the Planning Commission subject to the conditions as amended, seconded by Mrs. Bradley, and carried unanimously.

Budget funds

The Board reviewed a correspondence from the staff of the City of Lawrence which indicates that the tentative approved budget for the planning office for 1979 is \$114,875, an approximate 16% increase over the 1978 budget. Of this amount it is requested that the County fund approximately 24.4% of this tentative amount or \$28,050. After review and discussion it was moved by Mrs. Bradley that we agree to budget this amount of funds for the purpose of the joint planning office operation for the year 1979, seconded by Mr. Neis, and carried unanimously.

LeRoy McDermott, Coordinator of the Drug Abuse Council, appeared before the Board to provide notification that confirmation had been received from the State Department of Social and Rehabilitation Services that the Douglas County Drug Abuse Council's Model Community Prevention Program has been approved. Mr. McDermott informs the Board that the grant will be for the period of twelve months, from 1 July 1978 until 30 June 1979, and will bring \$29,998 in state funds into Douglas County in support of this project.

The Board noted receipt of a correspondence from Raymond Shaffstall, Acquisition Agent for the Kansas Department of Transportation, with relation to the purchase of right-of-way on Tract No. 29 for Project No. 23 AHL 1593 (2), known as the Clinton Parkway. Attached to Mr. Shaffstall's correspondence are the following enclosures: Deed, Contract, Temporary Easement, Voucher, Revised Offer, Acquisition Report and Negotiators Statement. Tract No. 29 is purchased from Dorothy F. Booth and Arden Booth by general warranty deed in the total amount of \$7,320, which includes 2.12 acres for right-of-way in the lump sum of \$5,300, 0.02 acres for temporary easement in the lump sum of \$10, 0.36 acres for temporary easement in the lump sum of \$145, and damage in the lump sum of \$1,865. After review of these documents it was moved by Mrs. Bradley that they be approved for payment from the special highway improvement fund, subject to 70% reimbursement on the project, seconded by Mr. Neis, and carried unanimously.
