The Board of County Commissioners of Douglas County met in regular adjourned session with two members of the Board present. Mr. Whitenight was absent due to vacation.

Approved the minutes of the meeting of July 31, 1978.

Monthly Fee reports

Ted McFarlane, Douglas County Ambulance Service Manager, notified the Board that Sid Apps will terminate on August 8, 1978, and Joe Thibodeau will terminate on August 2, 1978.

Mr. McFarlane recommended that the Board not accept any of the bids for the purchase of an ambulance vehicle which bids were opened on June 12, 1978. Mr. McFarlane stated that in his opinion none of the vehicles are worth their respective bid price.

The Board reviewed a recommendation from James Paddock, administrative judge, which indicates to this Board his approval for a request for an increase in salary for Kent Noble, probation officer, upon the six-month anniversary of his employment with Douglas County. It is recommended that Mr. Noble's present salary of \$850 per month be increased in the amount of \$47 per month, making a monthly salary of \$897 effective 5 August 1978. Judge Paddock also requested an increase in salary for Linda Allen, probation officer, upon the two-year anniversary of her employment with Douglas County. It is recommended that Ms. Allen's present salary of \$976 per month be increased \$54 per month, making a monthly salary of \$1030 effective 22 July 1978. After discussion it was moved by Mr. Neis that these recommendations of the administrative judge be approved, seconded by Mrs. Bradley, and carried.

Tom McGee, engineering division manager, appeared before the Board to present a contract for the purchase of highway right-of-way on Bridge Project No. 11.74N-21.00E between Frank L. Quiring and Joan H. Quiring, husband and wife, and the Board of Commissioners of Douglas County. This contract provides for a lump sum payment of \$284.80 for 0.24 acres of right-of-way easement, 0.08 acres of temporary easement for borrow and channel improvement, and 20 rods of barb fence. After discussion it was moved by Mr. Neis that this contract be approved, seconded by Mrs. Bradley, and carried.

Mr. McGee then presented a contract for the purchase of highway right-of-way on Project No. FAS 23-RS-1347(7) between Russel V. Houk and Betty Jane Houk, husband and wife, and the Board of Commissioners of Douglas County. This contract provides for a lump sum payment of \$450 for 0.26 acres of right-of-way and includes allowance for irregularity of boundary, 0.26 acres of soybeans, and abstracting. The Board reviewed three quotes for a 4-drawer, legal size, filing cabinet for the County Commissioners office.
