Mr. Dooley, then presented Supplemental Agreement Change Order No. 4 on Project DCL 75-1 for the Vermont and Massachusetts Street Bridges over the Kansas River. Supplemental Change Order No. 4 is a Special provision to the Standard Specifications, Edition, 1973, Stone Riprap, Section 2.5, Sources of Materials to add the following sentences:

The Toronto and Leavenworth limestone ledges from the M.R. Hamm Quarry No. 4, North Lawrence are approved for the source of stone protection materials provided the gradation and other requirements of this Special Provision are met.

This change order does not alter the basis of payment of any bid items from those shown in the Contract Documents and Specifications and no other changes are made under the Change Order.
