Mike Dooley, Director of Public Works, appeared before the Board to recommend the acceptance of one additional spare rim, 20" x 8.0", per truck in lieu of the second suspension seat which had been designated in the specifications on the purchase of two new dump trucks from Landmark Ford. After discussion it was moved by Mr. Neis that this recommended substitution be accepted, seconded by Mrs. Bradley, and carried unanimously.

Change salary install-
ments.*

The Board considered Home Rule Charter Resolution No. 78-9-1 which is a charter resolution exempting Douglas County, Kansas, from certain acts of the State legislature applicable to Douglas County, but not uniformly applicable to all counties, said acts being those requiring salaries and wages for elected county officers, certain appointed county employees, and other county wages and salaries in Douglas County, Kansas, be paid in twelve equal monthly installments. By the authority vested in the County Commission by the terms of K.S.A. 19-101a and K.S.A. 19-101b, as amended, the Board resolves to exempt itself from the provisions of the laws of the State of Kansas defined by K.S.A. 28-168 and K.S.A. 28-812. It is resolved that the salaries and wages of all county officials and employees of Douglas County shall be paid at such intervals as may be determined by the Board of County Commissioners. The Board may determine the frequency of such payments and may make changes in the frequency of payments as they shall determine to be proper or necessary. In accordance with terms of K.S.A. 19-101b, this Charter Resolution shall be published once each week for two consecutive weeks in the official county newspaper and shall take effect sixty days after final publication unless it is submitted to a referendum in which event it shall take effect when approved by a majority of the electors voting thereon. After complete review of the terms of this charter resolution it was moved by Mrs. Bradley that it be adopted, seconded by Mr. Neis, and carried unanimously.
