The Board reviewed a recommendation from the Administrative Judge regarding salary increases for three employees in the District Court. The recommendations are as follows:

(1) That Dolores Norris receive a one-year raise for merit. Her salary currently is \$642 and it is recommended that she be increased to \$674 per month, effective September 30, 1978.

(2) That Glenna Fraser receive a two-year raise for merit. Her salary currently is \$657 and it is recommended that she be increased to \$673 per month, effective September 30, 1978.

(3) That Wanda Kring receive a two-year raise for merit. Her salary currently is \$678 and it is recommended that she be increased to \$695 per month, effective September 30, 1978.

3rd Quarter report

The Board received from Wayne Kellum, zoning administrator, copy of the Third Quarter Report for 1978, which indicates a total estimated value of building permits declared to be \$25,411,550 and total fees received to be \$1,088. The Douglas County Treasurer notified the Board of the receipt of a check from the U. S. Department of Interior, Bureau of Land Management, in the amount of \$13,585, which is a federal payment in lieu of taxes which is paid to Douglas County on the approximately 20,571 acres of federally owned land in Douglas County. This check is to be credited to the general fund.
