Interested persons discussed future of home

The Board met with Ms. Petey Cerf, a representative of KINH, and Jessie Bran-son, Eleanor Smith, and Harriet Nehring to discuss the status of Valleyview Nursing Home. This group reviewed the current physical condition of the home and proposed to the Board that a new facility should be built and that it should be in the skilled care classification, and that the current home should be converted to providing care for ambulatory persons. After a lengthy dis-cussion the Board agreed to take the matter under advisement and submit the reports received to the Valleyview Advisory Board for their review and fur-ther recommendation to this Board.

The Board met with Fremont Hornberger, maintenance supervisor, to discuss the parking situation in the lot south of the judicial and law enforcement facting lot discussed center and in the smaller lot between the judicial and law enforcement center for with Hourdane and the courthouse as we prepare to move back into the old courthouse. Af-ter lengthy discussion it was agreed by the Board that the parking lot be-tween the judicial and law enforcement center and the courthouse shall be made available for visitors parking only, including two spaces specifically reserved for handicapped persons.
