This contract is for the purchase of approximately 5.75 acres of right-of-way easement, approximately 128 rods of woven fence, 59 rods of barb fence, and included in this lump sum payment is an allowance for irregularity of fencing which requires many corner posts, very irregular permanent boundary, abstracting, and allowance for rebuilding a ditch crossing in pasture south of project sta. 384+80 by the landowner. The total lump sum payment designated for this contract is \$10,400. After review and discussion it was moved by Mrs. Bradley that this contract be approved, seconded by Mr. Neis, and carried unanimously.
