The Board noted receipt of the following from the State of Kansas Department of Social and Rehabilitation Services: A check as reimbursement for the 15% incentive on the Title IV-D Incentive payment for child support collections for the month of October, the amount of \$184.50, and a check for Out of State Incentive per Title IV-D Cooperative Agreement in the amount of \$20.58, both of which shall be reimbursed to the general fund-commissioners budget. of which shall be reimbursed to the general fund-commissioners budget.

After discussion and review it was moved by Mrs. Bradley that this contract be approved, that the \$30,000 be remitted to the Department of Social and Rehabilitation Services as soon as possible, and that the balance of levied funds, \$24,000, be remitted directly to Cotton wood Incorporated for its programs and developments which are not subject to federal match, seconded by Mr. Neis, and carried unanimously.
