Letter in re. to bid
for Phase II*

The Board made note of receipt of a correspondence from Raymond E. Olson, engineer of secondary roads, Kansas Department of Transportation, relating to Project No. 23 AHL 1593(2), Clinton Parkway. The letter provides notice that the low bid for Phase II, concrete pavement and bituminous surfacing, was J. A. Tobin Construction Company of Kansas City, Kansas, in the total amount of \$3,895,418.88. The letter indicates that Kansas Department of Transportation has found this bid to be satisfactory when compared with the engineer's estimate, and Kansas Department of Transportation believes that the contract should be awarded to the low bidder. A resolution has been forwarded to Douglas County for our adoption if the bid is considered acceptable to the county. Mr. Olson's correspondence indicates that upon receipt of resolution and approval of the Secretary of Transportation, the contract will be awarded. The letter also points out that the local share of County matching funds will be in the amount of \$1,285,489, and that this remittance should be made on or before August 6, 1979.

Private road
easement

Wayne Kellum, zoning administrator, and Robert Russell appeared before the Board to request the approval of an easement for a private road for purposes of obtaining approval for three building sites. Mr. Kellum indicates that this request is for a 70 foot private road easement in the Southeast 1/4 of Section 6, Township 14 South, Range 21 East in Douglas County, Kansas, more fully described as follows: Beginning at a point that is (S 88° 58' 26" W) 1469.99 feet from the Southeast 1/4 of said Section 6 thence (S 88° 58' 26" W) 70.00 feet; thence (N 00° 11' 25" W) 1537.46 feet; thence (N 88° 58' 26" E) 70.00 feet; thence (S 00° 11' 25" E) 1537.46 feet to the point of beginning. This 70 foot private road easement will serve as an ingress and egress for three residences to be built. After discussion it was moved by Mr. Neis that this request be approved with the understanding that this private road will not be the responsibility of the township or county to maintain, seconded by Mr. Cragan, and carried unanimously.
