Employ Mike Malone, district attorney, appeared before the Board to recommend the employment of Linda S. Bollinger in the position of legal secretary, at a salary of \$617 per month, effective July 16, 1979. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mr. Cra-gan, and carried unanimously.

JudithAussylief Mr. Malone notified the Board of the following terminations: Judi Tricia Lynch Crossfield on July 31, 1979 and Tricia A. Lynch on August 3, 1979. Judith E.

Empley Ernest Coleman, federal funds consultant, and LeRoy McDermott, Douglas County Mentana Rennited drug abuse coordinator, appeared before the Board to recommend the employment (CETA) of Montana Bennett in the position of secretary-clerical, at a salary of \$553 per month, effective July 16, 1979, under the CETA Title VI program. After discussion it was moved by Mr. Neis that this recommendation be ap-proved, seconded by Mr. Cragan, and carried unanimously.

Ted McFarlane, Douglas County Ambulance Service Manager, appeared before the Board to present the Douglas County Ambulance Service Financial Highlites as of June 30, 1979.

Mr. McFarlane then presented the Board a copy of a letter from Dave Lamon, vice president of The Horton Company, Columbus, Ohio. The letter states that The Horton Company will participate in a special program for replacement of the inverter for the 1975 Chevrolet Horton 450 ambulance. The letter further states that a 1000 watt unit today retails for \$780 but due to the situation, they will furnish Douglas County with a Vanner 1000 watt, which is a far superior unit, in the amount of \$395. After discussion and Mr. McFarlane recommended that this amount be approved, it was moved by Mr. Cragan that the Board accept this recommendation, seconded by Mr. Neis, and carried unani mously. mously.

Mously. As stated in the minutes of July 12, 1979, representatives from the Lawrence Jaycees appeared before the Board for a decision on their request for ap-proval of a Special Temporary Use Permit to hold a Country Festival on Sat-urday, August 25, 1979, from 1:00 p.m. to 1:00 a.m. on the Homer Welsh Farm, 14 miles southwest of Lawrence, with the proceeds to be used for Muscular Dystrophy and other local charities. Also present were Dan Young, county counselor; Wayne Kellum, zoning administrator; and Rex Johnson, sheriff. After discussion it was moved by Mr. Neis that while the intended uses of the proceeds of the country music concert are for worthy civic causes and the sponsorship of the concert is by the Lawrence Jaycees, a highly respected organization, this Board has concluded from the presentation made by the app-licants that the Special Temporary Use Permit should be denied. Reasons for denial include the expense of providing adequate law enforcement for a crowd of up to 5,000 people; the expense of Clean-up along rural roads; possible traffic congestion; and the fact that as admitted by applicants, such a con-cert attracts some persons who may cause drug or alcohol problems.
