(3) That access to lots 17 & 35 be restricted to Highland Drive and lots 2 & 13 be restricted to Twin Ridge Drive. In addition, that lots 15 & 16; 36 & 37; and 38 & 39 share one access road cut per pair from Leconom Township Road 563. That we grant the applicant further review on lots 36, 37, 38, and 39 if shared access points become a problem due to the slope of the land.

(4) That a utility easement be added between lots 9 & 10 and lots 29 & 30 for Southwestern Bell Telephone Company; and,

(5) That a statement be placed on the plat stating there is a letter on file in the County Public Works Office regarding the apportionment of costs for road and drainage improvements for this subdivision.

Motion seconded by Mr. Cragan and carried unanimously.

The next item considered by the Board was Item No. 6, Final Plat of The Bluffs, a residential county subdivision containing approximately 79.6 acres, generally described as being located two and three-quarters mile west of Lawrence on Middle Road (County Road 438) and three-quarters mile north of Township Road 352, and is submitted by Young and Brockway Engineers for Paul Sloan. After discussion it was moved by Mr. Neis that the Board approve this final plat and variance for the acceptance of dedications and easements, subject to the following conditions of the Planning Commission:

(1) That the applicant's engineer certify that all lots are pinned or that a performance bond in an appropriate amount (as determined by the County Public Works Department and set by the Board of County Commissioners) be filed with the County Engineer; and

(2) That a performance bond for the construction of roads to "county rock road standards" and for the necessary traffic control devices and road or street signs be filed with the County Engineer in an amount deemed appropriate by the County Commission (based on an estimate from the Public Works Department).

Motion seconded by Mr. Cragan and carried unanimously.

No further business, the Board adjourned to meet on Monday, August 6, 1979.
