The Board considered consultant contract for the Fiscal Year 1979-80 with Ernest J. Coleman. After considerable discussion on the matter it was moved by Mr. Neis that Douglas County retain Mr. Coleman in the position of Douglas County Revenue Sharing consultant at the annual fee of \$12,900 to be paid in twelve equal installments on or before the last day of each month commencing on July 31, 1979, plus approved travel and other miscellaneous expenses.
