in firing range Travis Brann, emergency preparedness coordinator, and Keith Brecheisen from Air Treaters, Inc., appeared before the Board to discuss the modifications to the firing range. Tests run on December 3, subsequent to Mr. Brecheisen's installation of his equipment, did not meet the required standards and therefore Mr. Brecheisen proposed that with the Board's permission he would exchange one of the air handling units previously installed for a larger unit, Model 2600, and fabricate a temporary air plenum in an effort to gain greater control of the air flow and meet the required air standards. This exchange of units and additional work to be performed would not increase the cost from that quoted in previous correspondence. After discussion it was moved by Mr. Neis that the Board approve Mr. Brecheisen's request to continue his efforts to achieve the required environmental standards, seconded by Mrs. Bradley, and carried.

II Mike Dooley, public works director, appeared before the Board to review the utility agreement between Cities Service Gas Company, Oklahoma City, Oklahoma, Douglas County Board of Commissioners, and Secretary of Transportation on Project 23 RS 1528 (2) Phase II. This utility agreement is to relocate facilities of the utility which are located wholly or in part on private easements between Highway Stations 348+00 and 372+00 as shown on the plans of said project. It is indicated that the work to be accomplished will be performed by contract in the estimated total cost of \$50,705 with 100% of the cost of the project to be borne by the county. After review of the terms of the utility agreement it was moved by Mr. Neis that it be approved and forwarded to the Secretary of Transportation for their review and approval, seconded by Mrs. Bradley, and carried.
