By this resolution, the County Treasurer is ordered to credit the amount of \$319,450 to the Special Highway Improvement Fund from the Road and Bridge Fund in accordance with the statute, further that all such money credited to this Special Fund shall be used for the purpose of the construction or reconstruction of highways, bridges, roads and streets and necessary incidental facilities subject to the hereinbefore cited statutes. After discussion it was moved by Mr. Neis that this resolution be approved, seconded by Mrs. Bradley, and carried.
