Policy set for  
3 mile limits*

The Board considered Resolution No. 80-5 which resolution establishes the following policy for review of zoning and subdivision requests within three (3) miles of a corporate city's limits:

Whenever a development proposal requiring zoning and subdivision review is located in the unincorporated portion of Douglas County and within three (3) miles of the corporate city limits of the cities of Baldwin City, Eudora, or Leocompton, it shall be the responsibility of the Lawrence-Douglas County Planning Commission to notify the affected city and arrange a joint hearing of both planning commissions to review said development proposal. Said hearing shall be held at the Douglas County Courthouse following proper notice to the public. Following said hearing, the Board of County Commissioners shall receive a recommendation from each planning commission for their consideration during the final review process.

After discussion it was moved by Mr. Neis that this resolution be approved, seconded by Mrs. Bradley, and carried.

No further business, the Board adjourned to meet on Monday, January 21, 1980. There will be no meeting on Wednesday, January 16, or Thursday, January 17, as Mr. Neis will be on a personal business trip and Mr. Cragan is ill.
