Bob Duver, noxious weed director, appeared before the Board and recommended to the Board the acceptance of the low bid for 4,162 gallons of 2,4-D which bids were received at the office of the Shawnee County noxious weed director. The low bid for this product is from Pueblo Chemical & Supply, Iola, Kansas, for the following:

The total bid is in the amount of \$35,813.82. Five bids were received. It is designated in the Douglas County specifications that this 4,162 gallons of 2,4-D is to be delivered no later than May 1, 1980. After discussion it was moved by Mr. Neis that this low bid be accepted, seconded by Mrs. Bradley and carried.

sale of 2, 4-D

Mr. Duver then presented figures which indicate the administrative cost per gallon of 2,4-D for the year 1980 is recommended to be set at the rate of \$0.68 per gallon. By applying that recommended administrative cost figure to an average cost per gallon of materials on order and on hand of \$6.22 per gallon, a figure of \$6.90 per gallon is applied for an overall cost per gallon on the average. In accordance with the terms of the statute of the State of Kansas, Mr. Duver recommends that we set the rate of \$5.15 which is 75% of the total cost of product and administration. After review of this recommendation it was moved by Mr. Neis that we accept the \$0.68 recommended for applied administrative charges and that we set the rate of \$5.15 per gallon as our net per gallon charge to the customers of Douglas County for the year 1980, effective April 21, 1980, seconded by Mrs. Bradley, and carried.
