Mr. Dooley then presented the Board a voucher for signature to the State of Kansas on Highway Safety Project No. RE 80-11-11 in the amount of \$2318.54 for engineering services and \$737.97 for equipment which is partial payment for engineering services and equipment for a traffic safety study. Mr. Dooley then presented the Board three copies of a Supplemental Agreement, Change Order No. 5 to the Agreement dated November 27, 1974 with Finney & Turnipseed, consulting engineers, Topeka, Kansas, for the Vermont and Massachusetts Street Bridges over the Kansas River and for specified bridges in the County. This supplemental agreement provides for plan and construction engineering services for Bridge No. 09.00N-00.74E and Bridge No. 10.00N-01.00E. Both of the bridges included in the supplemental agreement are on land owned or under the control of the Federal Government. After discussion it was moved by Mr. Neis that this supplemental agreement be approved, seconded by Mr. Cragan, and carried unanimously.

Fremont Hornberger; Earl Van Meter, Douglas County extension director; and Ernest Coleman discussed updating and improving the arboretum at the Douglas County 4-H Fairgrounds. Mr. Van Meter recommended that the Board approve the quote from Pence Garden Center, Lawrence, Kansas in the amount of \$474 for shrubs, trees, and ground cover. Mr. Van Meter also recommended that the Board approve the amount of \$298.93 from other nurseries in the state and also the amount of \$155.25 from Custom Engraving, Lawrence, for signs to label plants. After discussion it was moved by Mr. Neis that the Board approve the recommendations which total \$928.18 and also that the Board would approve an amount of \$1,000 from 1980 revenue sharing funds for this improvement, seconded by Mr. Cragan, and carried unanimously.
