Mike Dooley, public works director, appeared before the Board and presented Resolution No. 80-14. The Board finds and determines upon the basis of an engineering and traffic investigation that the speed for the following described county road or highway, to-wit: Beginning at the Quarter Section corner between Sections 3 and 10, Township 13 South, Range 19 East, in Douglas County, Kansas, said point being on the center line of Clinton Parkway, thence westerly on the Section Line between Sections 3 and 10 a distance of 2662.45 feet to the Section corner common to Sections 3, 4, 9, and 10, Township 13 South, Range 19 East; thence westerly on the Section Line between Sections 4 and 9 a distance of 2670.22 feet to the Quarter Section corner between said Sections 4 and 9, thence westerly on the Section Line between said Sections 4 and 9, a distance of 2670.13 feet to the Section corner common to Sections 4, 5, 8, and 9, Township 13 South, Range 19 East; thence westerly on the Section Line between Sections 5 and 8, a distance of 2657.98 feet to the Quarter Section corner between said Sections 5 and 8, said corner being the P.I. of a curve to the right with a radius of 2864.79 feet; thence on a deflection angle of 7°14'50" to the right a distance of 767.92 feet, more or less, to the P.I. of a curve to the left with a radius of 2864.79 feet; thence
